



WHEREAS the Settlor is desirous of establishing a public Charitable Trust for Social, Cultural, educational and Economic upliftment of the masses and economically backward sections and Charitable objects and purposes in India hereinafter expresses and has decided this day to set apart a Sum of Rs.20,000/- for the creation of a Public charitable Trust.




AND WHEREAS the above persons have consented to act as trustees and have accepted the aforesaid sum of Rs.20,000/- as the initial trust Property. Now therefore a public charitable trust is hereby Created Under this Deed of Trust Subject to the following terms and conditions:-

NOW THIS INDENRTURE WITTNESTH AS FOLLOWS:-

- 1. In order to established this Public charitable Trust a Sum of RS. 50,000/only by the Settlor is deliversed and made over to the trustees, with intent to part with all his rights, title, interest and claim there in and vest the same in the trustee, to have and hold the same and all other properties that may for time being represents the trust, estate together with all additions and accretion there to all accumulated income thereof and all other properties that may be acquired out of same or otherwise may thereafter be subject to the Trust (herein after referred to as the Trust properties) for the Charitable object and purposes and uses here in after expressed with power and on the Terms and Condition and concerning the same.
- 2. The Trust Shall be Called —"T.S.B. TRUST" (hereinafter referred to as the trust) under the Indian Trust Act 1882. The Charitable Trust with its Head Quarter East Singbhum Jharkhand India.
- a) The Registered office of the Trust is Situated AT- Mukherjee Building, Pardih Chowk P.O- Pardih, P.S. Mango, East Singhbhum, Jharkhand, Pin 831012.

This office may be shifted to such other place as the trustees deem it necessary.


The Settlor hereby conveys the sum of Rs.20,000/- for the creation of the Trust unto himself and the following persons as above mentioned:-

- 5. Object of the Trust.






AIMS AND OBJECTIVES OF THE TRUST:-


The main objective of this trust is to arrange & Established All type of 1) Educational, and Higher Education, School, College, Civil Cad, Electrical Cad, Archi Cad, Interior Design, Mechanical Cad, Interior Cad Fashion Design, Computer Institute, Automobile training Institute, Engineering College, B.Ed College, ITI, Paramedical & Pathological training Institute, Physical, Medical, Management, Higher Education AIEEE, MAT, CAT, JAT, Merit Scholarship all management Entrance Exam, event Management, carrier fair, Education fair, Professional, Vocational and Information Science & Technology based educational activities. Scholarship test, Merit, all India Basis, Education Certificate, career fair of educational fair, entrance and scholarship exam for technical and professional colleges in India, Education and Admission Consultancy, Career guideline seminar, Trust will provide educational facilities to the weaker sections of the society for which we can start or help to start institution imparting primary secondary, higher and Technical education in different discipline including certificate diploma, degree, courses. The Trust can establish or grant for facilities in imparting professional Technical and vocational courses to train youths for employability or self employment. To provide facilities to the students needy and meritorious by way of grants scholarships, coaching fees, educational loan etc. To establish coaching centers, book bank, and computer education centers. To publish journal new letters periodical books, news papers souvenir etc. To run and establish printing press, recording centers, production centers, operate the same individually, commonly, or jointly.





- 2) To promote function literacy among villagers, farmers, wage-earners and other person irrespective of gender through mass literacy campaign and vocational education.
- To conduct various type of capacity and skill orientation training programs for girls and women like sewing, knitting, dairy farming, poultry farming, leaf plate making, for their economical position development.







- Erect buildings or structures, whatsoever to further any purpose or purposes of the trust and to maintain develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.
- Take or receive any gift, whether money or property, immovable, donations in the form of debentures, stocks, shares or securities in any company or society whether incorporated or not or whether by gift by a person living or by legacy bequests, will or foundation and whether subject to any special trust or for the securing of such contributions for funds as from time to time be deemed expedient.
- Alienate by way of sale, mortgage, lease, release loan, charge, hypothecation pledge, exchange, hiring out, gift or otherwise with or without security of properties of funds of the trust or any portion or portions thereof including the making or giving of subscriptions, contribution, assistance pecuniary or otherwise to such institutions, bodies or persons as from time to time deemed necessary or expedient.
- Lend money free of interest, invest, lay aside, deposit in bank otherwise deal with money or funds of the trust not immediately required for the objects of the trust and to subscribe or purchase, acquire, hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market, in conformity with the provision contained in section 20 of Indian Trust Act. 1882
- Borrow or raise funds with or without security in any manner the trust may think fit and repay the same.




- 35) To encourage and promote family welfare activities among needy people.


- 44) To issue appeals raise funds and accept gifts, donation subscriptions in cash or in kind and any property either movable or immovable for the achievement of the objective of the trust.




- 79) To promote and protect natural herbs and plants by cultivation, preservation, storage, processing, demonstration, creating botanical garden and providing necessary training.

No member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.

AND GENERALLY to do in all public, charitable purposes fo public benefit without any discrimination of Caste, Creed, Colour, Gender, Religion, Faith, Race or any Nationality. That in case any of the objects of the Trust are held to be non charitable within the meaning of section 2 (15) of the Indian Trust Act, or any statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.

Rules & Regulation of the Trust:-

- 1. This shall be public Charitable Trust and the benefits of this Trust shall ensure to the public without distinction of Caste, religion etc.
- 2. The trust created by the Settlor is not and shall not be revocable.
- 3. The funds and income of the Trust shall be utilized towards the achievement of the objects.
- 4. The salary amount shall be given to the trustee who will give his full time to the benefit of the Trust and which will be fixed by Board of Trustees.
- 5. MEETINGS The Board of trustees shall meet at least in three months if not oftener to transact business of the trust Five days notice shall be given of such meetings, the quorum for the meeting shall be five. Any three trustees may in writing requisition the secretary to convene a meeting of the Board of trustees clearly indicating the subject matter to be discussed. On receipt after giving five days clear notice.

In case the secretary fails to convene such a meeting, the three trustees themselves may convene a meeting by giving notice of seven clear day to the other trustees and decision taken at such a meeting shall be valid



and binding provided that at least eight of the trustees attend such meeting and the providing officer shall have a casting vote in case of equality of votes. Notice of all meetings shall be sent by ordinary post under a certificate of posting. If however in the opinion of the president, the calling of meeting of the trustees in impracticable for any reason to be recorded in writing, the secretary may got opinions of the trustees by circulating the files concerned on the subject matter and place them before the president, who shall take a decision in conformity with the opinion of majority of Trustees.

Power of the Board of Trustee: The board of trustee is empowered to perform and exercise the following acts deeds and powers

- (a) The Board of trustees may receive money or donations in cash or in kinds from any person or board estate for the purpose of board estate for the purpose of object which are consistent with the object of board or intentions donation of donors, which are approved by public. Such donation which may include money as donation will be disbursed in accordance with the tenets of public and managed and controlled by board of trustee.
- (b) Conduct or defend or compromise legal actions, appoint legal advisor for conduction of legal proceeding and to perform all such acts incidental to them by themselves or through their accredited agents.
- (c) Execute all documents relating to the immovable properties or the any loan secured or obtained by the trust.
- (d) The trustees shall enter into contracts of arrangements with third parties as may be the majority of trustees in writhing at meeting duly called for the purpose.
- (e) The trustees shall act jointly and difference of opinion arises at any time amongst them in relation to the doing or forbearing to do anything or otherwise, the opinion of the majority shall prevail, and be binding, and shall be effectually carried out.
- (f) The board of trustees may delegate any or all their power to anyone or



(g) The board of trustees is fully empowered to carry out the aims and objects aims and objects of this trust in any manner it deems fit.

Area of operation of this trust shall be all over India. The total number of Trustees shall not exceed ten and should not be less than Three.

All the trustees shall be residents in India and any trustee who leaves India permanently shall vacate his office.


A trustees cease to hold the office:-

- (a) On the death.
- (b) On his resignation
- (c) On his becoming insane.
- (d) On his becoming insolvent.
- (c) On his being expelled by the Board of trustees, for acting or having acted against the interest of the trust by a majority vote, provided such trustee has been given a reasonable opportunity of explaining his conduct to the Board of Trustees.

The Board of Trustees shall elect one among themselves as the MANAGING TRUSTEE and such a person shall hold the office till he resigns. The Board of trustees shall also determine the powers, duties, responsibilities and other terms and conditions connected therewith. The Board of trustees shall have power to vary the terms and conditions of his office.

Prafulla Kumar S/o Tetar Mandal will be President, Amit Ranjan Chakraborty, S/o Subhash Chandra Chakraborty shall be Secretary, Shamma Khatoon, W/o Amit Ranjan Chakraborty, shall be Treasurer, Alka Harsh, W/o Man Mohan shall be Member of the Trust and remuneration will be given to aforesaid as

decided by the Board.



Vesting and management: - the right, title, interest, the management and control of the properties and affairs of the trust shall be vested in the board of trustees. The trustees may by themselves or through an agent or agents employed by themselves or an agent or agents employed by themselves or an agent or agents employed by them manage and deal with the trust property in such manner as be most beneficial to the interest of the trust.

President:- The President shall be in charge of and responsible for the safe custody of all records relating to the administration of the trust and its properties. He shall convene the meetings of the board of trustees under the directions of the president and maintain regular record of all the proceedings of such meetings. All correspondences and financial statements and return required in connection with the management of the trust will be carried and prepared by the President.

Secretary The Secretary shall in consultation with other trustees, co-opt two trustees, possessing qualifications and experience, as specified and could assist in the execution of the project and programmes of the trust. He shall have the right to take decision in matters for the appointment and removal of the Trustees. He shall consult the profession and subject experts particularly the Advisor or Advisors, before taking any important decisions. He shall hold this post and position till his lifetime and shall authorized to nominate his nominee or representative as and when felt necessary. He shall have right to constitute/dissolve any committee for smooth running of any institutions. The Secretary shall be the chief executive officer of the trust.

Treasurer The treasurer shall receive and disburse all the moneys of the trust and maintain or cause to be maintained proper accounts of same. All loggias, donations, and subscriptions including money payable as income from properties shall be paid to the treasurer whose receipt will be valid and binding on the trust.

With a view to carrying out of the objects of the Trust herein above mentioned and to manage and administer the trust funds and without prejudice to the generality of any power whereby or by law conferred on, implied or voted in the Board of Trustees, the Board of trustees shall have the following powers.

To apply and use the funds for all or any of the objects of the trust and/or to accumulate the surplus applied portion of income and invest the same, subject to the provision of the Income tax Act, 1961 as amended from time to time, relating to accumulation of income and investment thereof funds of the trust shall be invested according to the modes prescribed under the Income Tax Act, 1961.

To receive any money or other assets in any shape or form as gift or donation and to hold the same as capital fund and/or apply it for furthering the same.


To receive security and apply it as per law.

To invest the funds from time to time In such manner as may be decided upon by the Trustees from time to time to dispose of alter or vary. the Investments from time to time to realize the Investments in conformity with the provisions of the Income Tax Act.

To compromise, compound, abandon, submit to arbitration or otherwise Institute any actions suits, proceedings, Claims or other things. Whatsoever arising out of the administrators of the trust fund and to enter into execute and do, such agreement, instruments and composition or arrangements, releases and other things as may seem expedient without being liable or responsible for any loss occasioned by any act or thing so done by them in good faith.

To acquire or to dispose off through mortgage hire, lease or otherwise movable or Immovable, tangible or intangible properties, and rights and benefits and to manage the same.

To receive, collect or realize or cause collection or realization of all income that accrue or become due on all or any Investment and to grant receipts and discharges.



To represent the trust in all courts original and appellate or before judicial or quasi- Judicial authorities and other authorities, departments of Government, semi-Government or local authority.

To open and maintain Trust accounts with Schedule bank and operations of such accounts shall be jointly by with Secretary (President/ Treasurer/ Member), jointly withdrawned by Cheque. And otherwise decided by the managing trustee and all member through resolution passed in trust meetings.

To sign and verify all pleadings, memorandum or appeal, petitions and applications of all kinds and to engage lawyers and other professionals and to take all such other necessary steps.

To borrow or raise any money that may be required by the trust upon such terms as may be deemed fit and secure any moneys so borrowed by Mortgage or charge of all or any part of the asset belong to the Trust.

To pay out of the "Trust funds, salaries, wages, rent, building maintenance, repairs and other expanses relating to the trust, its administration, management of its activities or its other affairs.

To start a business of purchasing the goods and sale in profit on behalf of the Trust and the profit amount shall be of Trust.

To start a scheme for benefit of the Trust. To appoint and/or dismiss staff executives, officials, caretakers, attendants and other employees on such terms as the Board may think fit.

To appoint committees or sub-committees from among the members of the Board and or alongwith others and assign duties and to frame with such rules or business as the Board shall think fit, and to alter or vary the same from time to time, provided that such rules of business shall have be inconsistent with the terms of these presents, the Board shall be entitled to frame, constitute and regulate the procedures of such committees or sub-committees.

To decide all questions arising in the administration of trust and including all questions relating to the interpretation of these presents the administration of the any institution maintained by the trust or concerning

any thing or any matter relating to, connected with or arising out of these presents or the operation thereon. The decision taken by the Managing trustee and Secretary in all or any of the matters aforesaid shall be final.


The Board of Trustees shall conduct the activities of the trust in accordance with the stipulations set out herein the Board of Trustees may delegate all or any of the powers vested in them to such person(s) For such period as they may deem fit and may at any time revoke, vary, alter, such powers so delegated. But last power to do the aforesaid shall be in the hand of Managing trustee and Secretary.

The trustees have power to frame such bye-laws, subsidiary rules and regulations and shall have further power to add, delete or amend the same from time to time as may necessary for the conduct of their business provided that the rules and regulations so framed and the amendments to the effect are not inconsistent with the objects of the trust and also the provisions of the Income Tax Act, 1961 Governing Charitable Trusts.

The persons enumerated in these presents shall be exercised by the Board strictly in conformity with the .1 conditions laid down in the Income Tax Act, 1961 (43 of 1961) amended from time to time, so that the income of the trust will be exempt from the Income Tax and the donors will get deduction in respect of their donations under Section 80G of the Income Tax Act, 1961 for each and 3 every assessment year.

To do all other acts, deeds, matters and things which may be deemed necessary for carrying out the objects of this Trust or its administration.

The trustees shall have the power to amend, alter or rescind any of the provisions of the trust in a manner not inconsistent with the object the trust and to interpret their meanings whenever the rules and regulations framed do into cover any emergency or is ambiguous provided that such change or interpretation do not conflict with the aims and object of the trust. If any difficulty arises in giving effect to the provisions of this deed of trust the majority of the trustees may by circulations or otherwise make such provisions not inconsistent with the deed of trust as appears to be necessary or expedient for removing the difficulty.



The board of trustees shall be the final authority in making decisions relation to any matter of the said trust not covered by this trust deed including the transfers of its assets an liabilities or its terminations.

The office of the trustees shall be honorary but they are entitled to draw such allowances as are prescribed by the board for carrying out their duties.

- (a) Any trustee may retire on giving notice of one calendar month_ in writing of his intensions to do so.
- (b) The trustees may reimburse themselves or pay and discharge out of the said trust properties all expense's incurred in or for the execution of the objects of the trust an exercise of the powers vested in them.

The Board of trustees may appoint a Treasurer from among the Trustees. The Treasurer shall keep or cause to be kept proper books of accounts and records or cause to be audited once a year by a Chartered Accountant and the salary of the treasurer shall be fixed by the Board.

The official year of the trust will be the financial year.

All provisions of this deed of Trust as well as any rules and regulations framed by the Trustees shall be interpreted by the trustees.

The managing Trustee shall guide and direct the Secretary in regard to the administration of the Trust, The secretary shall be responsible to the Managing Trustee and the Board of Trustees in the absence of the Secretary, the Managing Trustee shall direct any other trustee to perform the duties of the Secretary.

The Trustees shall meet as often as necessary to transact the business of the Trust. There shall at all cost be two meetings of the Trustees in a year. The Secretary shall convene the meetings, in consultation with the Managing

Trustee. The Secretary shall be responsible to record the minutes of the meeting and to carry out the directions given or decision taken in such a meeting. He shall report to the Managing Trustee and the Board of Trustees the action taken by him in implementing the direction of the Trustees.

- The decision of the Board of Trustees shall be taken on the basis of A) majority votes, in the case of equality of votes, the managing Trustee in a meeting shall exercise a casting vote, in case of dispute the Managing Trustee shall have power to decide the dispute.
- b) The quorum for a meeting shall be two. If there is no quorum, the meeting could be adjourned and the requirement of quorum shall not apply for such adjourned meeting.
- It shall be opened to the Board of Trustees to adopt any resolution by circulating the same among the Trustees. Provided such a resolution is assented to by a majority of the Trustees. All the resolutions adopted by circulation shall be placed in the immediately next meeting of the Board of Trustees for recording the same.

Every Trustee and the Secretary of the trust shall be indemnified from out of the funds of the Trust against all the loss or expenses incurred in the discharge of his duties, except such as has happened through his willful negligence or dishonesty.

All legal proceedings by or against the trust shall be instituted in the name of the trust through its Managing Trustee.

The trustee shall have the power to alter or amend the provision of this deed of Trust, provided that such alteration or amendment shall not be inconsistent with t object of this trust as well as the provisions of the Income Tax Act, 1961 governing the Charitable Trust, provided further that the amendments shall not be given effect to unless approved by the Commissioner of Income Tax.

It is hereby declared that the Managing Trustee and Secretary shall have power to dissolve the Trust by 2/3rd majority of vote. Managing Trustee,



Secretary or any one Trustee duly authorized by the Board of Trustees shall have power to execute any document required to be registered under the law and it is further declared that such document shall be deemed to have been properly executed by the Trust

It is hereby declared that the Trustees have the power to dissolve the Trust by 2/3rd majority of vote and In such event, the assets remaining on the date of dissolution shall under no circumstances be distributed among the trustees, but the same shall be transferred to another charitable Trust, whose objects are similar to those of this Trust.
